
Colonel's Message:

- UPDATE Professional Standards Major
 - Position expected to be filled in about 30 days
 - Future Law Enforcement Priority Planning
 - Utilizing a contractor to create a Conservation Police Roadmap
- Recruitment / Retention Initiatives
 - More efforts placed on recruiting advertisements than ever before.
 - 30-second radio ads aired on 56 radio stations in 34 markets across Virginia. These 6,700 individual commercials will have an anticipated 5,400,000 listener impressions during the 30-day campaign.
 - Digital and traditional billboards along busy travel routes throughout the Fredericksburg area, Metro Richmond/Petersburg, Hampton Roads, and Rt. 360/Rt. 460 corridors. The recruiting messages on the billboards will reach an anticipated 7,000,000 people.
 - Active social media campaign, Facebook live, Instagram Instastories, CPO Spotlight have been underway for several months.
 - Applications are still coming in. The number of applications is trending below the most recent 2017 recruitment effort. However, the number of applicants from underrepresented groups are up.
 - NOTE: The Conservation Police Application Period has been extended through March 17th. Please share with anyone who is interested.

- Law Enforcement Internship Program
 - O.P.S. is hosting two internship opportunities for the 2021 spring semester.
 With the health and safety of both division employees and internship participants, internships are being conducted virtually.
 - Ms. Shelby Foosness is a senior Environmental Science Majors at Bridgewater College. She is working with Lt. Ham and the accreditation team to develop testing on the division's new written directives to help field staff better understand and implement the division directives. Ms. Foosness aspires to become a Virginia Conservation Police Officer.
 - Ms. Nadia Aparicio is a Senior Criminal Justice Major at Longwood University. She is working with Ret. Chief Lettner and Lt. Ham on researching a Law Enforcement Command Staff level "Communication and Meeting Structure" that focuses on addressing operational and administrative concerns or emerging problems in a strategic fashion leading to obtainable goals and objectives. Examples include Compstat Model, SARA Model, etc. which are used by numerous law enforcement and organizations across the globe to increase communications and operational efficiency.

Support Services:

- UPDATE Support Services Major
 - Message from Major Ryan Shuler: As stated in an earlier email to the field, I am very excited to begin this journey as your Support Services Major. Throughout my career I have recognized the importance of providing quality services and equipment to our field level staff so they can accomplish their mission. My new role will allow me the opportunity to explore new technologies, processes and equipment that will increase our efficiency and effectiveness as we serve the citizens of the Commonwealth. As a member of the Colonel's staff, I am a proponent of collaborative leadership and welcome new ideas and suggestions. Please feel free to contact me through the proper channels if you have any comments or suggestions on how we can improve our operations within the Support Services Division.

- Division Budget Update
 - As we currently develop the budget for the next fiscal year, we have identified a need to forecast future budgets to better understand our operational needs. One of the first steps in this process was forecasting our vehicle fleet needs based on current driving trends by using Voyager mileage data. Thanks to Sergeant Mark Brewer, we now have a Microsoft Access program that will allow the fleet management team to run reports that will identify our vehicle needs based on fiscal year, vehicle model year, region, district, etc. As we continue to review our budgeting process, we will look to expand our forecasting models to other areas of the budget to strategically target our most critical needs.

Grants

- In 2020, the law enforcement division submitted a FEMA Port Security Grant application for three projects that totaled \$500,000. The first project was for a 27' SAFE boat that would be assigned to the Middle Peninsula and help to support our public safety mission, while also assisting our other local, state and federal first responder partners that work within the maritime domain. The second project was for seven dual payload vessel mounted FLIR cameras that will replace aging FLIR cameras on some of the current agency SAFE boats. The third project was for training funds that could be used to host two NASBLA Tactical Operations Courses, two NASBLA Boat Crewmember Courses and Two NASBLA Pursuit and Stop courses. As an active member of the Port of Virginia Maritime Incident Response Team, we will sponsor these courses, provide most of the expert trainers and will open them up to our partner agencies. We were fortunate to receive funding for all three of these projects and the procurement process is underway. On February 25th, the 2021 FEMA Port Security Grant Notification of Funding was announced and we are already in the process of preparing the required documentation to seek \$250,000 worth of federal funding for three new projects aimed at equipment sustainability.
- Communications
 - Dispatcher Gavin Shaler completed Communication Officer Training Program.
 - Dispatcher Jennifer Garnett scheduled to return to duty near end of March.
 - Sgt. Bell and the Dispatch Supervisors, Bill Martin and Kevin Leonard, are in the process of reviewing all Communication Center General Orders and SOPs.
 - > Once completed, General Orders / SOPs will be moved to PowerDMS.
 - There will be another statewide DWR shutdown of the radio system in the near future (less than a day for VSP maintenance on the microwave tower).

- Fleet Management
 - The division has ordered nine 3/4 ton Ford 250 pick-up trucks equipped with diesel engines capable of towing our largest 27' SAFE boats. These trucks will be assigned to CPO's as their daily patrol vehicle; ordered this budget year by converting \$400,000's worth of personnel vacancy credits.
 - Four Chevy Trucks left to issue. Gary had a dealer rep come in recently to correct issues on two of them. Two others are ready to be issued soon.
 - Eight of the nine RAM trucks are in. Five of the eight have had new tires and decals installed already.
 - Ordering parts for the RAM trucks has begun. The division will be transitioning to a handheld light and siren control module, as well as going to a red/white/blue emergency lighting scheme. The addition of the red light is based on research that has identified red light as more visible during daylight hours.
 - Blue lights for boats as required by the new General Order are in for R2, R3 and R4. Notify Stan of any additional lights needed.
 - Remember to key your radios every 30 days.
