The modified regulation amendments presented by staff provided only 8 either-sex deer hunting days on private lands in Rockbridge County during the general firearms season and expanded the either-sex days on private lands in the county during the early and late muzzleloader season to full season, either-sex hunting as well as maintaining the existing late archery deer season. The amount to be utilized shall be defined upfront for each instance and shall include a repayment plan. This authorization shall only be exercised when it is not practical to bring the request to the full Board at a regular schedule meeting, and the Board shall be notified of any such action at or before its next regular meeting.
