Colonel Cobb reported:

- 1. VLEPSC State Re-Accreditation (First Term) Next Week
  - ➤ On-site Assessment of last four years, including:
    - Static Display and Ride-alongs
    - Facility and Evidence Inspection
    - File Review and Proof Compliance
- 2. Current Basic Academy Update (w/MRC enrollment)
  - > On Week 24, 13 of 14 DWR Recruits (4 of 5 MRC Recruits) 17 total
  - They are in Boat Operations Training this week (Buggs Island)
  - ➤ 14th Basic Academy Graduation on September 12
    - Fairmount Christian Church (6502 Creighton Rd, Mechanicsville)
    - Doors open at 1:30 pm Program starts at 2:00 pm
- 3. Current Recruitment Effort for 15th Basic Academy (February 25)
  - ➤ We received 418 completed applications
  - ➤ Applicants were then asked to complete a brief personal history questionnaire, and we received 213 responses
  - ➤ Based on further screening and the results of the written examination and the physical fitness testing, we currently have 97 applicants
  - They will be moving onto interviews on September 2-5
    - Followed by background investigations and polygraphs

Mr. Edmunds, and other board members had a brief discussion on "open field doctrine" that other states have for law enforcement and their concerns for Virginia law enforcement.

#### Hunting Dog Data Summary – 01/05/2025 to 09/30/2025

**HDOGS Incident Code**: This call type will be utilized when the complaint being made <u>does not</u> involve a violation of law, such as hunting dogs running at large across private property.

• DWR collects activity and species data for this complaint type.

**HVDOGS Incident Code:** This call type will be utilized when there is a hunting-related violation reported that involves a hunting dog. An example would be a hunter retrieving his dog while carrying a firearm on prohibited property.

• DWR collects activity and species data for this complaint type.

### Complaint Data:

- DWR received a total of 2080 hunting-related complaints from 01/05/2025 to 09/30/2025
  - o HDOG Complaints: 245
    - Species reported being chased was deer: 80
    - Species reported being chased was bear: 12
    - Involved dogs running across property w/o permission: 206
  - HVDOG Complaints:53
    - Species reported being chased was deer: 26
    - Species reported being chased was bear: 5
    - Involved dogs running across property w/o permission: 24
